

# The Facts:

## Signs of Inhalant Abuse

- Anxiety, excitability or irritability
- Spots or sores around the mouth
- Red or runny eyes or nose
- Chemical breath or odor
- Drunk, dazed or dizzy appearance
- Nausea, loss of appetite
- Paint or stains on body or clothing

## Long Term Effects

- Sudden Sniffing Death Syndrome
- Short term memory loss
- Hearing loss
- Limb spasms
- Permanent brain damage
- Bone marrow damage
- Liver & kidney damage
- Possible fetal effects similar to alcohol syndrome



## Sudden Sniffing Death Syndrome

The user can suffer cardiac arrest and die whether they inhale the 1st or 100th time. Inhaling gases like **Freon** is one of the causes of Sudden Sniffing Death Syndrome (SSDS).

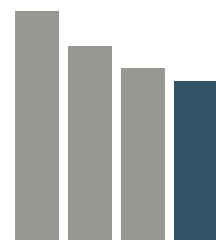

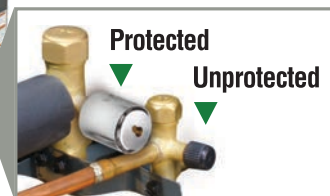
